#### **WARNING: RISK OF ELECTRICAL SHOCK**

Use only as described in this Therapure® 64oS manual. To reduce the risk of electric shock, do not attempt to service the product in any way other than in the manner described in the **"Cleaning & Maintenance"** section of this manual.

#### READ ALL INSTRUCTIONS BEFORE OPERATING THE AIR PURIFIER.

- » This product operates at 120V AC, 60Hz only.
- » Do not run cord under carpeting. Do not cover cord with throw rugs, runners, or similar coverings. Arrange cord away from traffic area and where it will not be tripped over.
- » Do not operate the product in any greasy environment, such as in the kitchen. This product is not intended to filter oil or grease from the air.
- » Do not use the Therapure® 64oS air purifier in bathrooms or other humid environments. Do not use near fireplaces or in areas where flammable or combustible vapors or products may exist.
- » Always unplug the power cord from the electrical outlet when the purifier is not in use, before cleaning, inserting or removing parts or before moving to another location.
- » Never run the air purifier unless it is fully assembled.
- » This appliance has a polarized plug (one blade is wider than the other). To reduce the risk of electric shock, this plug is intended to fit in a polarized outlet only one way. If the plug does not fit fully in the outlet, reverse the plug. If it still does not fit, contact a qualified electrician. Do not attempt to defeat this safety feature.
- » Always turn off all controls before unplugging the Therapure® 64oS air purifier from the outlet.
- » Attempting to service the Therapure® 64oS air purifier in any way that is not described in this owner's manual will cause the warranty to be voided and could cause serious personal injury to the user and/or result in considerable damage to the unit.
- » Do not place the cord near a heated surface.
- » Do not operate this product with a damaged cord or plug. Discard the product or return to an authorized service facility for examination and/or repair.

- » The TPP64oS and its remote is not a toy, do not allow children to play with the air purifier or remote control.

### IMPORTANT WARNINGS

### **UV Lamp Notice**

UV Light is harmful to bare skin and eyes and can cause temporary or cleanable loss of vision. Never look directly at the UV lamp while it is illuminated; doing so could cause loss of vision! Only view illumination through the window at the front of the unit. To prevent exposure to ultraviolet light, disconnect the power to the unit before servicing any part of the Therapure® 640S air purifier.

### **UV Lamp Disposal**

If the UV lamp breaks, turn off the unit. Do not operate the unit with a broken lamp. Do not use a vacuum to clean up breakage. Sweep debris into a plastic bag and dispose of properly. Contact your local waste management authority for instructions regarding recycling and the proper disposal of old lamp(s). 





Locate a level surface on which to place the Therapure® 640S air purifier near a 120V outlet (follow warnings in the **"SAFETY INSTRUCTIONS" and "IMPORTANT WARNINGS"** sections of this manual). Position your Therapure® 640S at least one foot (12 inches) from the wall. Plug in the unit.





### OPERATING THE THERAPURE® TPP640S

Before using the Therapure® 64oS air purifier, please read the following important information.

### **Safety**

- 1. Do not place near fans.
- 2. Keep both sides of the unit at least 1 foot away from a wall.
- 3 Do not place the unit near curtains.
- 4. Placing the unit close to the source of air pollution is an effective way to improve indoor air quality.



#### Note:

DO NOT run the Therapure® 640S with a broken filter. Replace the filter if the filter has a tear or a hole in it.

If the filter is damaged or needs replacement, please visit the Therapure® website at **envionproducts.com** to order for a replacement filter. Or call **1.800.875.8577**.

### **CONTROLS/SETTINGS:**


**Power Control** – To operate the Therapure® 640S, press the Power  $\Theta$  button to turn on the air purifier.

**Timer Control** – The Therapure® 64oS air purifier can be programmed to turn off after a preset amount of time. Press the "TIME" button to program the timer. Each press will add one hour up to a total of 24 hours. Keeping the button pressed will automatically increase to 24 hours, 1 hour at a time, after that it will turn back to off.

ION Generator - Press the "ION" button to turn on the IONs. Press it again to turn the IONs off.

**Fan Speed Control** – The Therapure® 64oS has three different speeds of cleaning, LOW, MED and HI. Press "SPEED" button to cycle the settings and select the fan speed you desire. The speed state will be shown on the LED display.


**Auto Mode** – The Therapure® 64oS is equipped with an air sensor to monitor the quality of your air. Simply press the "AUTO" button to activate the air monitoring system. The monitor will test the air quality and automatically adjust the fan speed to remove the air contaminants. The front of the display is equipped with LED lights to notify you of the air quality. **RED** color is for poor, **ORANGE** for fair and **BLUE** for good quality air.



**Clean Filter Indicator Light** – The Therapure® 64oS Clean Filter Indicator Light will turn on each time the filter needs to be cleaned. To reset the filter indicator, press the ION and UV/VOC buttons together for **3 seconds**. The CLEAN FILTER light will flash **3 times** and then turn off completely, indicating the unit has been reset.

**Dim Mode** – If the LED lights are too bright, activate the "DIM Mode" to turn off the LED lights and the lighted display. To turn on Dim mode, simultaneously press Auto and Time buttons. Power indicator, however, will remain lit.

**UV Control** – Press the "UV/VOC" control button for UV/VOC to turn on the UV lamp and the photocatalyst filter.


# Warning:

The remote control has a coin cell battery. Keep the remote and the battery away from Children. If the battery is ingested, immediately seek medical attention. Never put the coin battery in your mouth for any reason as they are easily swallowed accidentally. Discard coin batteries carefully.

#### **REMOTE CONTROL:**

Remove the remote from the plastic bag.

Remove the plastic tab from the bottom of the remote by gently pulling on the tab.



Turn the air purifier on and off by pressing the **POWER** button.

Control speed with the **SPEED** button.

Control the timer with the **TIME** button.

Turn the UV light on and off with the UV/VOC button.

Turn the Auto function on and off with the **AUTO** button.

Set the air purifier to Dim mode by pressing the **DIM** button.




### To Replace the Battery:

Replace the battery clip by pressing on the release tab while simultaneously pulling the battery clip out.

Only replace with: CR2025 Lithium cell battery.

Insert the cell in the battery clip with "+" facing up and insert the battery clip into the remote.

**Note:** When inserting the battery clip into the remote, turn the remote backside up.



### **CLEANING & MAINTENANCE**

Keep the Therapure 640S functioning properly by cleaning the cleanable HEPA-Type Filter every four weeks of use. More frequent cleaning will be necessary if the unit is located in an area with a high level of airborne contaminants (excessive amounts of smoke, pet dander, etc.).

Exposing the Therapure® 64oS to candle/oil/fireplace soot and smoke is not recommended and will require more frequent cleaning.


### Note: Always make sure the Therapure® 640S is turned off and unplugged before cleaning.


- » Vacuuming will restore performance of the cleanable HEPA-Type Filter. However, the filter may appear stained. This is normal and does not affect performance in any way.
- » Do not use water or any household cleaners or detergents to clean the cleanable HEPA-Type Filter.
- » The inlet grill may be cleaned (after unit is turned off and unplugged) with a vacuum or a slightly damp cloth.


### Cleaning the cleanable HEPA-Type Filter

- 1. Release the inlet grill by pressing on the locking latch (see diagram of Main Parts).
- 2. Remove the inlet grill from the unit as shown below.
- 3. Grasp the left and right frames of the cleanable HEPA-Type Filter through the indentations on the sides of the filter enclosure and remove the filter.
- 4. To clean the cleanable HEPA-Type Filter, use the brush or crevice attachment with a vacuum cleaner. Run the attachment along the inlet and outlet side of the filter, cleaning between the crevices as much as possible. **Do not use water or any household cleaners or detergents to clean the cleanable HEPA-Type Filter.**
- Once the cleanable HEPA-Type Filter has been cleaned and checked for any possible damage, replace the filter back in the reverse direction described here. Plug in the unit and **hold down** the ION + UV/VOC button for 3 seconds. The clean filter light will go off and your cleaning maintenance is done.









### CLEANING & MAINTENANCE

### **Cleaning the Pre-Filter**

- Release the air inlet grill by pressing on the locking latch.
- 2. Gently remove the pre-filter from the air inlet grill.
- 3. To clean the pre-filter, simply submerge in warm soapy water. Gently lift and submerge the pre-filter several times until it is clean.
- Rinse the pre-filter with clean water and allow it to dry completely before placing it back to the air inlet grill.

### **Cleaning External Surfaces**

- 1. Turn off and unplug unit.
- 2. Use a washcloth slightly dampened with a little water and dishwashing soap to wipe the outer case surfaces.
- 3. Do not allow water to slip into the internal parts as this could damage your unit and result in electrical shock and injury to you.
- 4. Allow the unit to thoroughly dry before use.

#### **UV Lamp**

The lifetime of the UV lamp is up to 12 months of continuous, effective operation. After this time, the bulb may remain illuminated, but its effectiveness is greatly reduced. For maximum effectiveness, please replace the UV bulb annually.

If the lamp stops functioning or needs replacement, please visit our web site at envionproducts.com to order a replacement lamp. Or call 1.800.875.8577.


#### Caution:

- Do not touch the glass part of the lamp. Oil from fingertips will decrease the effectiveness of the lamp.
- Never operate the unit without a filter or with a damaged filter. UV lamp cover must be installed at all times. The UV light from the UV lamp will result in severe damage to eyes and could cause blindness.




### **CLEANING & MAINTENANCE**

Before replacing the UV lamp, make sure the Therapure® 640S air purifier is turned off and unplugged. Let the lamp cool down for 5 minutes before replacing it.

### Replacing the UV Lamp:

- 1. Release the inlet grill by pressing on the locking latch.
- 2. Grasp the left and right frames of the cleanable HEPA-Type filter through the indentations on the sides of the filter enclosure and remove filter.
- 3. Remove the two bolts used to fix the UV lamp cover and remove the cover out from the unit then unscrew the old UV lamp from the lamp base of the unit.
- 4. Install the new UV lamp into the lamp base of the unit.
- 5. Install the UV lamp cover with the two bolts on the unit.
- 6. Install the inlet grill on the unit.






### **Cleaning the Air Monitor:**

The TPP64oS is designed with an air monitor to track the quality of your air. Over time the monitor can become dirty and may require cleaning. The main symptom of a dirty air monitor is the LED display remains frozen on one light color. In order to clean the air monitor you must use a vacuum to clear the monitor chamber.

- 1. Power off and unplug unit.
- 2. Locate the 3 small vent holes in the rear of the unit just about the inlet grill. (Fig. 1)
- 3. Use a vacuum cleaner hose to suction any dust or dirt that may have accumulated inside the monitor chamber. (Fig. 2)







## TROUBLESHOOTING

PROBLEM	REASON	SOLUTION
Unit will not operate	Power button has not been turned on.  Unit is unpugged.  The inlet grill has not been installed & locked into place.	Press the Power button.  Check to ensure unit is plugged in.  Check to make sure filter and inlet grill is properly installed & locked into place.
Reduced airflow or poor filtering	The inlet or outlet grill may be blocked. Cleanable filter may be clogged.	Check to ensure nothing is blocking the air inlet & outlet. Check & clean the filter, if necessary.

IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, YOU MAY RETURN THE PRODUCT TO COMPANY WITHIN THIRTY (30) DAYS OF RECEIPT FOR A FULL REFUND.

#### 3. ARBITRATION PROCEDURES.
